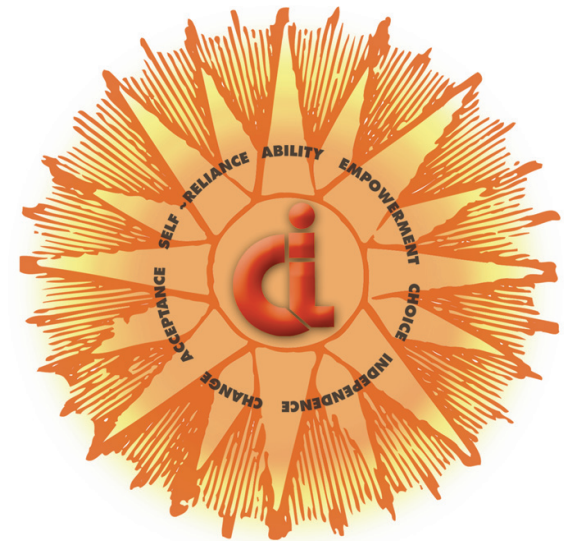

- Businesses may claim an income tax credit of up to 50% of eligible access expenditures that are over \$250, but less than \$10,205. The amount credited may be up to \$5,000 per tax year.
